



TRITON World Series - Minor Waiver/Release

RELEASE OF LIABILITY FOR MINOR PARTICIPANTS

READ BEFORE SIGNING

IN CONSIDERATION OF my child/ward _____
(Name of Minor Child/Ward) being allowed to participate in any way in any TRITON Kids or a TRITON World Series SHORT distance event, only, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19 or any other contagious infectious diseases) to my child from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS TRITON World Series and or any local or global partner; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE to the fullest extent permitted by law.
5. I, the parent/guardian, assert that I have explained to my child/ward: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement.



I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

Further to that, I understand and accept, Underage participants are allowed with the signing of this waiver if and only when it is NOT AGAINST the event's insurance policy, local laws by local governing bodies, and local sports official entities.

I understand that some of these permissions and authorizations maybe known only close to event date, and as such, the permission to participate, may be revoked and denied after the acceptance of this signed waiver, up to the competition day, without any compensation.

In addition, upon observation in the presence of the minor, the local organization, its officials, or TRITON World Series Head Office staff, for safety reasons, may consider the participation a high risk and NOT ALLOW PARTICIPATION at its own discretion.

The underage participant, may NOT, under any circumstances, be authorized to take part in ANY distance other than TRITON SHORT (age 15 or higher) or TRITON KIDS events (ages 8 – 14). If under the age of 8 years old, the child may NOT take part in any swimming or cycling competition or fun race / events, for safety reasons.

This signed waiver/release must be kept on file for at least 7 years or possibly longer if the player has been involved in a serious injury.
